He said that the FMLD had been a bit off in 2021 with which grants they would have available, and staff also lost sight of the grant as well. He said that the resolution in a standard format that was part of every grant application, and the grant will be for improvements to the community center kitchen.

Mayor A Riddile asked what sort of improvements. Administrator Reynolds said new cabinets and some stainless-steel surfaces, better sinks, more in alignment with a commercial kitchen.

Council Comments

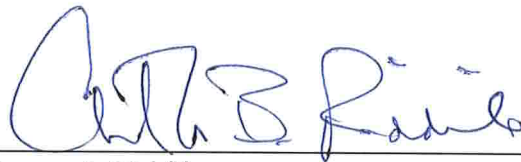
